Fresh Leaf Maryland Launches Statewide Campaign to Encourage Expungement of Cannabis-Related Records

Maryland – September 3, 2024 – Fresh Leaf Maryland is excited to announce the launch of a statewide media campaign to inform Marylanders about new laws allowing for the expungement of almost all cannabis possession criminal records in the state and to encourage individuals to expunge cannabis possession arrests, charges, and convictions with assistance from free and low-cost legal aid services.

New Laws Offer Fresh Start for Many Marylanders

Governor Wes Moore's mass pardon of low-level marijuana convictions is a crucial step toward addressing the injustices of cannabis criminalization. However, many are unaware that pardons alone do not remove cannabis-related arrests, charges, or convictions from public records. Expungement is essential for ensuring that these records don't hinder future opportunities. Even those who have received pardons can benefit significantly from expungement, as it shields records from public view, allowing for greater access to employment, housing, and other life opportunities.

Lauren Pruitt, Legal Director of FreeState Justice, emphasizes, "For decades, unjust cannabis laws have disproportionately impacted Black and Brown communities in Maryland and have contributed to the over-policing of these populations in the state.

Cannabis expungement provides an opportunity for individuals who have been penalized under outdated cannabis laws to clear their records."

Through various channels, including TV, radio, billboards, social/digital media, and more, this campaign aims to raise awareness about the benefits of expungement and connect Marylanders to legal aid and resources to assist in the process.

"The statewide campaign launched by Fresh Leaf Maryland is a significant step towards justice and equity. The collaboration among legal services organizations across Maryland exemplifies the power of unity and shared purpose in driving meaningful change. By facilitating the expungement of cannabis-related records, we affirm that past convictions should not hinder future opportunities." says Kirsten Gettys Downs, Executive Director of the Homeless Persons Representation Project (HPRP).
