## Maryland Legal Aid Sues Baltimore City Over Unconstitutional Tax Sale Auctions

In July, Maryland Legal Aid filed a federal lawsuit against the City of Baltimore, claiming the city's property tax sale auction process unconstitutionally strips property owners of their equity without fair compensation. The lawsuit, filed on behalf of the Edmonson Community Organization (ECO), argues that auctioning liens on properties with overdue taxes disproportionately harms vulnerable populations, especially low-income Black and disabled property owners.

Lee Ogburn, Maryland Legal Aid's Advocacy Director for Appellate and Impact Litigation, stated, "This case builds on the principle confirmed by the US Supreme Court just last year that 'a government may not take more from a taxpayer than she owes.' Baltimore City violated that principle when it took ECO's \$140,000 building for a \$2,500 tax bill and then offered ECO only \$2,500 for its loss."

The lawsuit aims to bring about systemic changes to Baltimore's tax sale practices, which have led to significant losses for property owners while generating negligible revenue for the city. This case highlights the broader struggle for justice and equity in property ownership and the fight against policies that disproportionately impact marginalized communities.


